- 2. Currently, have online trainings available 24/7 through links and website. All HMIS trainings, Coordinated Trainings, forums for intake, forms for release information and all others are available on the website.
- 3. Major project: Transfer of lots of clients from shelters to Central Valley Housing.

- 6. Ongoing projects: Inventory module to allow anybody who has access to HMIS to see how many beds are available in real time and in which shelters which will make reservation a lot more easier.
- 7. Will be engaging with all shelters providers to get the information out.
- 8. Got a lot of outreach data, and will provide additional reports on how many people are homeless in the community.
- 9. All updated information will also be available on the CoC website.
- 10. Planning to send out Feedback surveys on HMIS.
- 11. Will also be sending out the Housing Inventory Count and Sheltered Point Count by the end fo the year.
