# Status of the Collaborative Applicant: Greg Diederich:

• Currently recruiting and will close this Friday. Greg to reach out to HR. The goal is to quickly fill the position. The position is funded by a CoC grant and there could be additional funding that can be dragged down.

- Chris B of Neighborhood Preservation, who is the backbone of the division, has also given her retirement notice after working for the county for 35 years.
- Need to expedite the trasnsition.
- HCSA to help support taking the minutes.
- In Adam's absence, and by CoC By-Laws, the applicants can be Board Set until the position is hired or filled.
- Will have a forum for homelessness with United Way on Aug 25.
- Some of the issues planning to address are:
  - o How can the county take a marginal role
  - Have a written report for opportunities to align addressing homelessness, and to use this to approach the Board for funding for homelessness.
- Jon has expressed his appreciation for all the work Greg does to replace Adam and Chris
- Kate mentioned that information and applications can be reviewed and submitted to the site.
- CoC application Adam has the narrative, data, and draft placed in E-Nap.
- Should submit applications 4-5 days early.
- As per Peter, Adam has mentioned something that needs to be posted on the website. Has no idea what contents need to be but will make it happen.
